# **MARIA JOÃO CARRAPATO**



Maria João Carrapato was re-elected to the Board of Governors in November 2021, having previously been Chair of the Board from 2014 to 2020. Director of Investor Relations and Sustainability at NOS SGPS since 2020, Maria João led the Investor Relations team of NOS since 2007 and prior to that was responsible for Investor Relations at two other Portuguese PSI20 companies, Sonae Indústria and Sonaecom between 2000 and 2007. She started her career as a financial analyst at Banco Português do Atlântico (1994-1995) and later moved onto the equity sales team at Banco Português de Investimento (1995-2000). Maria João was a founding member and the first Chairman of the Portuguese Investor Relations Society, founded in 2009 and in 2020 was elected President of the Executive Committee of the Oporto

Cricket and Lawn Tennis Club. Maria João has a degree in Business Management from Universidade Católica Portuguesa (1994) and an MBA from the University of Oporto Business School (2004). The daughter of a British mother and Portuguese father, and herself with dual nationality, Maria João spent her early school years in the UK, until the age of 13, when she returned with her family to live in Oporto in 1984. Maria João has two children, both of whom completed primary schooling at OBS. Maria João has been awarded an MBE by Her Majesty the Queen on the 2021 New Year's Honors list, for services provided to British Education in Portugal.

# **ISABEL BARROS**

Isabel Barros is CHRO, Executive Board Member at MC, Non-Executive Board Member at Sonae Indústria and Bright Pixel. In May 2023 she integrated the Board of GRACE – Responsible Business Association.

In the 2019-2023 Quadrennial, she was President of APED (Portuguese Association of Distribution Companies) and Vice-President of the Executive Committee of CIP (Portuguese Business Confederation).

Since October 2022, she is Member of the Board of Católica Porto Business School Association and External Member of the Representatives Council of Faculty of Nutrition and Food Sciences at Porto University.

Since July 2022, she is member of the Editorial Board of Executive Digest Magazine. Since November 2020, she integrates the Board of Governors of Oporto British School.

In 2019, she was appointed Vice-Chair of BCSD (Business Council for Sustainable Development), a non-profit association that aggregates and represents more than



90 leading companies in Portugal, which are actively committed to the transition to Sustainability. Also, in 2019, Isabel was awarded by the WBCSD (World Business Council for Sustainable Development) in the category 'Excellence' of the Leading Women Awards, focused on the recognition of women leaders with a differentiated contribution to the Sustainable Development Goals (SDGs).

In 2015, she was nominated a member of the Executive Board of Junior Achievement Portugal (JAP), the Portuguese counterpart of the largest and oldest non-profit organization for education in entrepreneurship in the world.

With a degree in Psychology from the University of Porto and an MBA from EADA Business School Barcelona and Nagoya International School Japan, Isabel Barros is often a speaker and guest teacher in forums on Talent Management, Development and Leadership, sharing her knowledge and more than 20 years of experience in these areas, in a national and international context.



## **NATASHA BRIDGE**

Natasha trained as yoga instructor in 2014/15, Master in 2018 and was a yoga teacher at OBS for both children and staff from 2015-2019.


Natasha's three children were born in Porto and educated at OBS and in the UK.



In 2010 he was responsible for setting up together with the Fladgate



Nonexecutive director in several companies' boards (from retailing to finance) and nonprofit organizations. Research interests in Industrial Organization, Competition and Regulation, Corporate Behaviour and Finance. PhD in Banking and Finance – Cass Business School (London) – and a MSc in Internal Trade and Finance – University of Lancaster (UK), and research fellow at London on regulation and competition Business School. Álvaro is the Chair of Education Committee and his daughter was a student at OBS.

#### JIMMY SCRAGG



After reading Classics at Oxford University, Jimmy began his teaching career at Oundle School. From there he moved to the Classics Department at Eton College, where he also ran the boat club and was a CCF Officer. He went on to be a Housemaster for over eight years, heading a group of six other HMs. During that time, he covered the Director of Welfare role and worked as Ofqual's lead reviewer for the current GCSE and A level examinations in Classics. He was on Eton's professional development, academic development and staffing committees and chaired the Common Room's representative body. Jimmy has been a prep school governor, chair of governors at an academy in a deprived area of Slough, and a director of a multi-academy trust.

Jimmy is currently Deputy Head at Marlborough College.

#### **LUIS LOUREIRO**

Luis Loureiro came to Porto in 1991 to study Architecture. He joined Tecnopor in 1997 and worked in several projects in the equipment and industrial area until 2003, while developing at the same time a freelance activity. During this period, he received several awards for his work, namely the Municipal Prize of Heritage from Montemoro-Velho.

He joined Symington Family Estates in 2003, in the Património Department, becoming responsible for maintenance, projects and works in Vila Nova de Gaia and Douro and having subsequently assumed the position of Head of Department of Gestão do Património. In 2019 he was appointed to the board of directors as Director of Património, a position he currently holds further to being chair of the company's Coordination Committee.

During this period, he continued his studies, taking the General Management Course at Porto Business School in 2016-2017.

The works developed at Symington have been published in several specialized

magazines. He is the author and responsible for numerous works and projects carried out at Symington. His and his team's work at Symington has received several awards and prizes, having been invited and selected to participate in various exhibitions, publications and to present their work at various conferences and seminars. These works, which include the rehabilitation of Graham's 1890 Lodge, have received national and international recognition.

He is also affiliated with other associations, including the Factory House in Porto, where he is a Representative Member.
